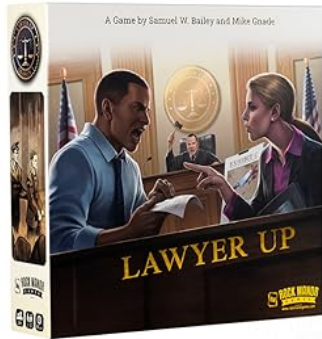

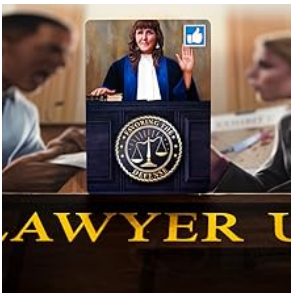
Lawyer Up is an asymmetrical two-player courtroom drama card game where one player is the noble prosecution and the other the steadfast defense.

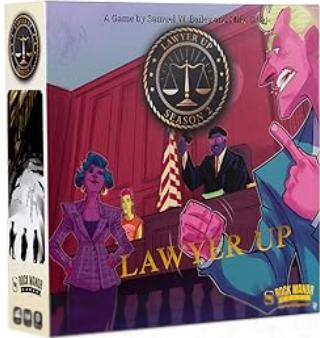
